Summary & Recommendations:

The company has been successfully verified as a “Genuine” trading company. However, the company is not a manufacturer of the product, therefore, the company is “reluctant” to provide complete address of the “factory”. It is normal for traders to try and protect the source factory, however, from a QC perspective, we recommend dealing with factories (wherever volumes permit). However, good traders can also be good suppliers, as long as their protecting the factory doesn’t interfere with the quality control process. The company seems to have a good online presence which is a good sign.

Suggestions for Next Steps

If you are satisfied with the results of the “company verification report”, you can consider moving ahead with your purchase. However, depending on the value of your order, we suggest you consider some of the following actions:

- If you are directly dealing with the supplier (in terms of the “Financial Transaction”) we strongly suggest you sign a contract with them and define all your terms and conditions. Please note that English Contracts have very little value in China, therefore it is recommended that the contract is written out in “Mandarin Chinese”.
- If it is not possible for you to sign a contract, or if the value of the order is fairly small (say less than \$5000) we recommend you raise a “Purchase Order” and clearly define all terms on it and ask the supplier to sign and send it back to you.
- We strongly recommend you carry out a Pre-Shipment Inspection (PSI) before the goods are finally delivered and put this as one of the terms of the “Purchase Order”. This not only acts as a strong deterrent but can also help ensure that faulty goods are spotted before they leave Chinese shores (after which it is usually too expensive to return them back).
